Old Business: Bob Gilmore reported on the UU Legislative Ministry and agreed to be the liaison, to further advocate workshops, following the UU Legislative Ministry, keeping UUFBC updated and gathering information. A Motion made

by Christine May for the UUFBC to join the UU Legislative Ministry for \$150.00 a year with Bob Gilmore to Chair. Ruby Jo Faust seconded the motion. All attendees were in favor. The Ministry program will fall under the Goal 2; Objective 2, of the UUFBC Strategic Plan.

Jack Harvey offered new information on UUFBC insurance policy. Jack was in discussion with People's First Insurance agent Daniel Oliver; these were the facility changes suggested: Raise Directors, Officers and Trustees liability coverage to \$250k and add employment practices liability for \$49 per year. Check umbrella coverage; Check workmen's comp for volunteers. Church Mutual - umbrella does NOT cover Directors, Officers, or Trustees coverage nor can it be added, also does NOT cover misconduct and molestation. Volunteers ARE covered for workmen's comp. A request for changes to facilities policy to remove requirements was agreed. Mr. Oliver stated the policy and premium currently would be hard to beat.

Jack Harvey also discussed clarification with regard to UUFBC policy for one-time, time line events.
